



## TERMS OF SERVICE

By using myDewetra, the data and the information prompted by Dewetra and made available free of charge by many providers, users abide to the clauses listed in the following terms of service

Dewetra is offered to the institutions of National Civil Protection Systems and other companies and Authorities (hereinafter: Users) with the aim of sharing data, models, information and tools for real-time monitoring and assessment of hydro-meteorological hazards and risks as well as to foster scientific knowledge and technologies for civil protection purposes.

The access to Dewetra –for a trustful collaboration between institutional bodies – is allowed only within the framework of Civil protection activities, through a private account that strictly cannot be transferred or sold to third parties. Any other use of the application is forbidden, without express prior written consent by the DPC to which all rights are reserved.

It is forbidden to delete or modified the copyright, the registered trademark or any other property right with respect to the way they are visualized in the available maps, layers, tables and figures. Users are prohibited to copy, reproduce, republish, post, publicly display, encode, translate, transmit or distribute in any way any images, datum or component, completely or in part as well as to use them differently than advised in the terms of service.

The static and dynamic data, information, models and tools provided by Dewetra, hereinafter generically called the Contents, are offered to scientific Users strictly for civil protection activities, in the framework of ongoing projects or programmes in collaboration and/or cooperation with the DPC and cannot be used for publication or other purposes, unless explicitly granted by the DPC.

Dewetra is suitable to be enhanced by means of contents produced and owned by other institutions and companies, yet any further development of the platform and/or the Content has to be agreed with the DPC.

Dewetra, being a hub of data retrieved, refined and developed by other institutions than DPC, cannot guarantee and therefore cannot be hold responsible for any inaccuracy or errors of the Content nor their unavailability or untimely availability.

Furthermore, notwithstanding DPC with the support of CIMA Research Foundation has designed Dewetra for high dependability and it is seamlessly working to further develop the platform, it has to be highlighted that DPC disclaims any loss, damages, or liability caused by any failure of performance, error, omission, interruption, deletion, defect, delay in operation or transmission
